

Executive Summary

We are excited to share findings from our second annual Michigan Insights Review. From March to May 2022, we surveyed and spoke with over 250 state and local policymakers in Michigan to understand policy priorities throughout the state and how the private and public sector can work on those issues.

While healthcare remains a top priority for Michigan policymakers, focus this year has shifted to infrastructure and education, as decision-makers grapple with questions around how to rebuild the state in a post-pandemic world.

Following a consequential midterm election, Michigan policymakers are aware that their constituents will be looking to them to work with the private sector to solve the issues they prioritized during their reelection campaigns. As leaders return to in-person engagement, policymakers want to see the private sector engaging on these foundational issues, placing an emphasis on direct collaboration with stakeholders, in order to benefit both local communities and the state as a whole.



This is the first report in a series that covers various top policy priorities in the state of Michigan. This report is an examination of overall policaymaker priorities for this year.



Top Issues in 2022

Infrastructure

Improving infrastructure in Michigan is the top concern for policymakers, regardless of their party affiliation. Forty-four percent of both Democrats and Republicans, as well as 45 percent of Independents, identify infrastructure as one of the top three policy priorities.



"So what's really important to the State of Michigan is certainly investment in infrastructure. We are adding a lot of the best practices that we experimented with during the pandemic...with an eye towards the future."

Education

Policymakers view investing in the education system as a priority that will have positive impacts on the workforce and economy.



"K-12 education is the most important thing that the state government does. I think it will always be the top issue."

Healthcare

Policymakers want to see more affordable and accessible healthcare options that include comprehensive mental health services.



"...My main concern is just that there is an **inconsistent network of care** around the state, and that **location becomes a really significant factor** in the amount and quality of care that folks can access."

Top Issues (cont.)

Economic Development

Policymakers are concerned with a shortage of workers in several key industries and believe improving the workforce is vital to economic development in Michigan.



"Whatever industry you talk to, they're lacking workers. I just was with [a company] last night. They need workers. The mental health industry needs workers. Manufacturers need workers. It doesn't matter. **Every industry in the state seems to be struggling to find enough workforce.**"

Environment

Policymakers are actively working to protect natural resources in Michigan.



"If you're looking out with any sort of long-term vision, **the most** important thing we can do for future prosperity is making sure that we protect clean air and clean water in our environment."

"We've had an issue over the last couple of years because folks think we don't have clean drinking water. Michigan is really pushing to demonstrate that we are the water state and we do take exceptional care of our surface and groundwater. It is definitely a focus across the aisle. It's not just a Democratic or Republican focus."


